State Attorney General to speak at Fall Luncheon Friday, October 19, at 12 noon at the Coast Bellevue Hotel



What is the fastest growing crime in the nation, costing consumers \$50 billion a year? Washington Attorney General Rob McKenna says that it is identity theft. At the PSA-PBK Fall Luncheon on Friday, October 19, he will speak on “The Attorney General’s Role in the Fight Against Identity Theft.” Attendees will learn how citizens can protect themselves and what to do if they become victims. McKenna has, among other things, convened the first statewide Identity Theft Conference and formed working groups to fight this trend.

Rob McKenna is Washington’s 17th Attorney General, succeeding Christine Gregoire in 2005. As the state’s chief legal officer, he provides legal services to state agencies, boards, and commissions. McKenna graduated from Sammamish High School in Bellevue. At the University of Washington, he earned a B.A. in Economics and a B.A. in International Studies--both with honors-- served as student body president, and was elected to Phi Beta Kappa. He received his J.D. from the University of Chicago in 1988, where he served on the Law Review.

Holding the fall luncheon in Bellevue rather than Tacoma is an experiment as our Association strives to serve its members better. The spring luncheon will continue to be held in Seattle.

Delta Chapter news

The Washington Delta Chapter at the University of Puget Sound is looking forward to spring semester, when they will be hosting a PBK Visiting Scholar, Laurel Thatcher Ulrich of Harvard University, on

February 25 and 26, 2008. Recently appointed the 300th Anniversary University Professor, Ulrich joined the Harvard faculty in 1995, prior to which she was at the University of New Hampshire. Her major fields of interest are early American social history, women's history, and material culture. She is the author of *Good Wives: Image and Reality in the Lives of Women in Northern New England, 1650-1750*; the Pulitzer Prize-winning *A Midwife's Tale: The Life of Martha Ballard Based on Her Diary, 1785-1812*; *The Age of Homespun: Objects and Stories in the Making of an American Myth*; and, most recently *Well-Behaved Women Seldom Make History*. Professor Ulrich is a member of the American Philosophical Society and a Fellow of the American Academy of Arts and Sciences. She was named a MacArthur Fellow in 1992. Recipient of a Guggenheim Fellowship and two awards from the National Endowment for the Humanities, she has been honored with awards for excellence in teaching at Harvard.
